SPECIAL WARRANTY DEED

Together with all and singular the hereditaments and apportenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues, and profits thereof, and all the estate, right, title, interest, claim or have ditaments and appurtenances: TO HAVE AND TO HOLD the said premises as above described, with the appurtenances, unto the Grantee, its heirs and assigns forever.

Grantor also hereby grants to the Grantee, its successors and assigns, as right, and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the declaration of condominium, aforesaid, and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said declaration for the benefit of the remaining property described therein.

This Deed is subject to all rights, easements, covenants, conditions, restrictions and reservations contained in said declaration the same as though the provisions of said declaration were recited and stipulated at length herein.

Grantee is a purchaser of a vacant unit described in Exhibit A prior to the conversion of the real estate to a condominium.

Grantor covenants, promises and agrees, to and with Grantee, its heirs and assigns, that it has not done or permitted to be done anything whereby the said premises hereby granted are, or may be, in any manner encumbered or charged, except as herein recited. Grantor also covenants, promises, and agrees that it WILL WARRANT AND DEFEND, subject to the following permitted exceptions:

- (6) Declaration of Easements, Restrictions and Covenants for West Park Place Condominium;
- (7) party walls;
- (8) alleys, roads and highways (if any);
- (9) title exceptions pertaining to lier's or encumbrances of a definite or ascertainable amount which may be removed by the payment of money at the time of closing and which Grantee shall remove at that time by using the loan proceeds to be paid upon delivery of this Deed;
- (10) matters over which the title insurer is willing to insure;
- (11) Use Agreement dated May 10, 1995 by and betweer. Secretary of Housing and Urban Development and West Park Place Residents Association for Preservation;
- (12) Grant Agreement dated May 10, 1995 by and between Secretary of Housing and Urban Development and West Park Place Residents Association for Preservation;

- (14) Grantee's mortgage (if any).
