And the Court having jurisdiction of Plaintiffs and all the parties to this suit who are interested in the real property legally described herein and the subject matter hereof and all parties interested being before the Court, and the parties having waived a trial by jury, and representations of counsel in open court, having been heard; and

The Coart being fully advised in the premises, and having reviewed documentary valuation evidence, finds and determines that the total just compensation, to be paid by Plaintiffs herein is the total sum of TWO THOUSAND FIVE HUNDRED AND NO/100 (\$2,500) DOLLARS for the fee simple title to the subject property, legally described on attached Exhibit A.

Treasurer of Cook County, on behalf of the person or persons interested in the subject property, the award of just compensation, being the total sum of FWO THOUSAND FIVE HUNDRED AND NO/100 (\$2,500) DOLLARS, without statutory interest, within sixty (60) days of entry of this Final Judgment Order, and Final Judgment is entered in accordance herewith.

IT IS FURTHER ORDERED AND ADJUDGED, that were deposit of said TWO THOUSAND FIVE HUNDRED AND NO/100 (\$2,500) DOLLARS with the County Treasurer as aforesaid, Plaintiffs herein shall be thereby vested with fee simple absolute title to said real estate property.

IT IS FURTHER ORDERED AND ADJUDGED that this Court finds no just reason to delay the enforcement of or appeal from this Final Judgement Order entered herein.
