

### **EXHIBIT A**

#### **LEGAL DESCRIPTION**

Parcel 1:

Unit 1005 and Parking Space P-145 in Kinzie Station Condominium as delineated and defined on the plat of survey of the following described parcel of real estate:

That part of Lots 7, 8, 9, 10 and 11 in Block 11 in Canal Trustee's Subdivision of lots and blocks in the original town of Chicago in the Southwest Quarter of Section 9, Township 39 North, Range 14 East of the Third Principal Meridian, according to the plat thereof recorded August 31, 1848 and re-recorded Semember 24, 1877 as Document 151607 in Cook County, Illinois.

#### Parcel 2:
