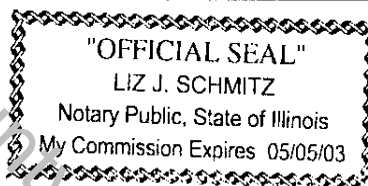


EXHIBIT A

PARCEL 2:
