### **RECITALS**

WHEREAS, Gratkowski and Seller entered into the Articles dated December 17, 1993, which were recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 03064556 in connection with the property legally described on the attached Exhibit A. The Articles were subsequently amended by an Amendment to Articles of Agreement for Deed dated October 21, 1998, which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Doc. No. 08168946; and

WHEREAS, the Buyer and Seller now desire to further amend the Articles, as previously amended to reflect that Gratkowski's interest thereunder, as Evyer, has been assigned to the Limited Partnership subject to the consent of the Beneficianes as may be required by the Articles, as amended, evidenced by the Beneficiaries' execution of this Second Amendment; and

WHEREAS, Gratkowski shall personally guaranty to the Beneficiaries the repayment obligations under Section 2 of the Articles, as amended by separate guaranty to be executed by Gratkowski contemporaneously with his execution of this Second Amendment.

NOW THEREFORE, in consideration of the mutual covenants and promises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. The foregoing Recitals are incorporated herein by this reference as though fully set forth.
- The Limited Partnership shall be deemed the "Buyer" under the Articles, as amended and the Limited Partnership shall be substituted for Gratkowski as the "Buyer" uncreunder. Gratkowski and the Limited Partnership, each, represent and warrant to the Leneficiaries that: Gratkowski is the owner of 100% of the membership interest in Projects LLC, a single member Illinois limited liability company; Projects LLC is the General Partner of the Limited Partnership (which in turn holds a 40% interest in the Limited Partnership); Gratkowski also owns a 30% interest in the Limited Partnership as a limited partner; and, Fred Grimes holds the remaining 30% interest in the Limited Partnership, as a limited partner.
- 3. Gratkowski shall cortemporaneously with the execution of the Second Amendment, execute and deliver to the Beneficiaries a separate, written guaranty of the repayment obligations under Section 2 of the Articles, as amended.
- 4. All other provisions of the Articles not specifically amended hereunder shall remain in full force and effect.
- 5. The parties acknowledge that Buyer shall have the right to record this Second Amendment with the Office of the Recorder of Deeds of Cook County, Illinois.
