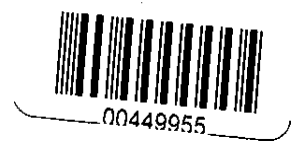

COOK COUNTY, ILLINOIS

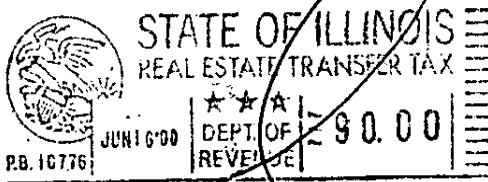

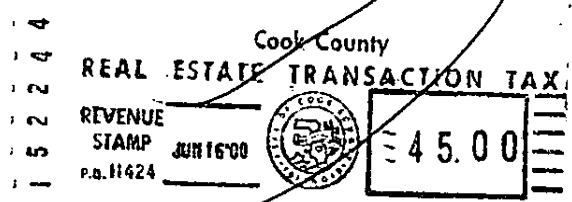


