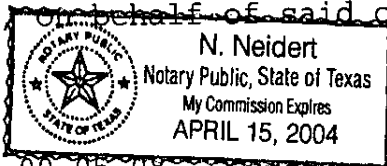

THAT PART OF THE SOUTH 1 ACRES OF THE NORTH 10 ACRE OF THAT PART OF THE NORTH WEST 1/4 OF SECTION 5, TOWNSHIP 35 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING WEST OF THE CENTER LINE OF RIEGEL ROAD RUNNING NORTHERLY AND SOUTHERLY THROUGH SAID NORTH WEST 1/4 SOMETIMES CALLED THE CHICAGO AND VINCENNES ROAD, DESCRIBED AS FOLLOWS:
