FOURTH MODIFICATION AGREEMENT TO MORTGAGE AND REVOLVING NOTE

This **Fourth Modification Agreement to Mortgage and Revolving Note** (this "Agreement") is effective as of the 30th day of November, 1999, between **Green Acres Country Club**, an Illinois not-for-profit corporation (hereinafter referred to as "Borrower") and **AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO** (hereinafter referred to as "Lender").

WITNESSETH

WHEREAS, on November 15, 1995, Mortgage executed and delivered to Lender a certain Revolving Note in the original principal amount of Four Hundred Thousand and 00/100 Dollars (\$400,000.00), due on November 30, 1996 (the "Revolving Note").

WHEREAS, on November 15, 1995, Borrower executed and delivered to Lender a certain Revolving Note in the original principal amount of Two Million Five Hundred Thirty Two Thousand Eight Hundred Eighty Four and 86/100 Dollars (\$2,532,884.86) ("Term Note"), and (ii) Term Note in the original principal amount of Three Hundred Thousand and 00/100 Dollars (\$300,000.00), which has subsequently been paid in full;

WHEREAS, the Revolving Note and the Term Note are secured by, among other things a Mortgage and Assignment of Leases and Rents and Security Agreement executed by Borrower dated November 15, 1995, and recorded in Cook County, Illinois on November 17, 1995, as Document Number 95800533, as modified by that certain (i) Mortgage and Revolving Note Modification Agreement dated November 18, 1996, and subsequently recorded in Cook County, Illinois as Document Number 96904223, and (ii) Second Mortgage and Revolving Note Modification Agreement dated November 28, 1997, and subsequently recorded as Document Number 97941991, and (iii) Third Mortgage and Revolving Note Modification Agreement dated November 28, 1998, and subsequently recorded as Document Number

08126874 (collectively, the "Mortgage") encumbering real estate legally described on Exhibit A attached hereto and made a part hereof.

WHEREAS, Borrower has requested that Lender extend the Maturity Date (as defined in the "Revolving Note") until November 30, 2000; and

WHEREAS, the parties hereto desire to amend the Revolving Note and Mortgage as set forth herein.

NOW THEREFORE, in consideration of the premises and the mutual promises and agreements hereinafter made by and between the parties hereto, the said parties do hereby mutually agree to modify the Mortgage as follows:

1. Borrower acknowledges that the current outstanding principal balance of the Revolving Note is Three Hundred Twenty Five Thousand and 00/100 Dollars (\$325,000.00).
2. The Revolving Note is hereby amended as follows:
 - A. The Maturity Date defined on Page 2 of the Revolving Note is hereby changed to November 30, 2000.
 - B. Any reference in the Revolving Note to the Mortgage shall hereafter refer to the Mortgage as amended hereby.
3. The Mortgage is hereby amended as follows:
 - A. Any reference in the Mortgage to the Revolving Note shall hereafter refer to the Revolving Note as amended hereby.
4. Borrower acknowledges and agrees that Lender is under no obligation to provide any further renewals of the Revolving Note after the Maturity Date.
5. All other Loan Documents as defined in the Mortgage are amended in that references to the Revolving Note and Mortgage shall be deemed to refer to the Revolving Note and Mortgage as amended by the terms hereof.
6. Except as specifically modified by the terms hereof, the Revolving Note, Mortgage, and other Loan Documents shall be and remain in full force and effect and shall continue to govern the rights and obligations of the parties with respect to the loan or loans evidenced and secured hereby.
7. This Agreement shall be binding upon and inure to the benefit of the Borrower, and Lender, and their respective successors and assigns. This Agreement shall be governed by the laws of the State of Illinois.

IN WITNESS WHEREOF, the parties hereto have signed, sealed and delivered the Modification Agreement as of the date first written above.

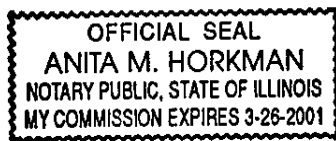

CERTIFICATE OF NON-APPLICABILITY OF THE ILLINOIS RESPONSIBLE PROPERTY TRANSFER ACT

The undersigned, being first duly sworn hereby states as follows:

A. The undersigned is the current owner of real estate and the improvements located thereon commonly known as GREEN ACRES COUNTRY CLUB, Illinois, legally described in Exhibit "A" attached hereto and made a part hereof ("Property").

B. Bank has requested that the undersigned comply with the Illinois Responsible Property Transfer Act (765 ILCS 90/1 et seq.)
