POWER OF ATTORNEY made this 2 day of May, 2000

1. The undersigned, Stephanie F. McNeil, of 1332 East Desert Flower Lane, Phoenix, Arizona hereby appoints Michael S. Roberts and Maureen A. Kipkos of One North Franklin, Suite 1200, Chicago, Illinois 60606 as her attorney-in-fact (my "agent") to act for her and in her name (in any way she could act in person) with respect to the following powers, as defined in Section 3-4 of the "Statutory Short Form Power of Attorney for Property Law" (including all amendments), but subject to any limitations on or additions to the specified powers inserted in paragraph 2 or 3 below:

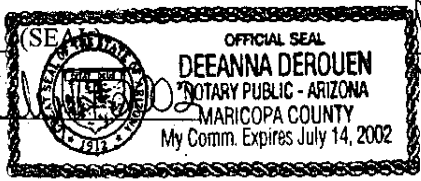
