- 4. The Contract was entered into by one or more of the Owners and the work was performed by Leopardo with the knowledge and consent of Owners. Alternatively, Owners specifically authorized Silver Cinemas' or Silver Cinemas' agents to enter into contracts for improvement of the Real Estate. Alternatively, Owners knowingly permitted Silver Cinemas or Silver Cinemas' agents to enter into contracts for the improvement of the Real Estate.
- 5. Leopardo last performed work under the Contract on or about March 17, 2000.
- 6. As of the date hereof, there is due, unpaid and cwing to Leopardo, after allowing for all credits, the principal sum of Four Hundred Ninety Eight Thousand Eighty Dollars (\$498,080) for the Tenant Work (as that term is defined in the Contract) under the Contract, for which, with interest, Leopardo claims a lien against the Real Estate.
- 7. This Original Contractor's Amended Claim for Mechanics Lien amends Leopardo's prior lien in the amount of \$498,050 filed in the Office of the Recorder of Deeds, Cook County, Illinois as Document Number 00411260.
