


JUDGMENT ORDER

This matter coming before the Court on Plaintiff's Petition To Prove-Up Damages, which includes affidavits attesting to the amounts owed by Defendant, and Default Judgment having already been entered against Defendant and in favor of Plaintiff.

IT IS HEREBY ORDERED that final judgment be entered in favor of Plaintiff and against Defendant in the amount of \$31,449.98. That amount is comprised of \$10,936.30 in unpaid fringe benefit contributions revealed to be owed by an audit of Defendant's records; \$3,040.54 in interest on unpaid contributions through April 15, 2000; \$213.27 in accrued interest for 1 month and 9 days since April 15, 2000; \$3,253.81 in statutory double interest charges; \$874.90 in liquidated damages equal to 8% of unpaid contributions per the governing collective bargaining agreement; \$2,195.00 in audit costs; and \$10,936.16 in attorneys' fees and costs.
