AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR 50 EAST BELLEVUE CONDOMINIUM ASSOCIATION

THIS AMENDMENT to the Declaration of Condominium Ownership and of Easements, Restrictions, Covenant and By-Laws is made on June 7, 2000 by 50 East Bellevue Condominium Association, ar Illinois not-for-profit corporation (the "Association").

RECITALS

The Declaration of Condominium Ownership and of Easements, Restrictions, Covenant and By-Laws (the "Declaration") was recorded in the Office of the Recorder of Deeds of Cook County on November 1, 1979 as Documents No. 25221794.

Pursuant to the Declaration, the Association is responsible for the management of the Property subject to the terms of the Declaration. This Arrendment to the Declaration is being made by the Board of Directors of the Association (the "Boa d") pursuant to authority granted by Section 31 of the Illinois Condominium Property Act as amended (the "Act"), and pursuant to resolution adopted at a duly called meeting of the Board.

This Amendment evidences the combination of Units 1105 and 1106 (the "Affected Units") otherwise legally described on Exhibit B-1 to this Amendment, created by the Declaration and the combination of the percentage interest of the common elements appurtenant to the Affected Units.

Yuri Starodubsky is the holder of fee simple title to the Affected Units and joins in this Amendment to evidence his consent to the terms hereof.

NOW, THEREFORE, the Board adopts the following Amendment to the Declaration as of the date hereof:

- 1. <u>TERMS</u>. Terms used herein if not otherwise defined shall have the same meaning as set forth in the Declaration.
- 2. AMENDMENT. Attached as Exhibit A to the Declaration is a survey identifying the horizontal and vertical planes of each Unit and the Property (the "Survey"). Attached hereto as Exhibit A-1 is a survey which amends, in part, Page 10 of the Survey (the "Added Exhibit A") as initially recorded with the Declaration. Added Exhibit A delineates the new boundaries of Unit 1105/1106 created hereby (which Unit 1105/1006 is mislabeled in said Exhibit A-1 as "Unit 1107") and is hereby incorporated as part of the Survey attached to the Declaration
- 3. <u>DESIGNATION OF COMBINED UNIT</u>. The Affected Units shall hereafter be referred to as "Unit 1105/1106' and all references in Exhibits B and C to the Declaration to Units 1105 and 1106 shall now refer to Unit 1105/1106.
- 4. ADJUSTMENT TO PERCENTAGE INTEREST. The percentage interest in the common elements allocated to Units 1105 and 1106 in Exhibit C to the Declaration was .79012% and .53359%, respectively. The percentage interest in the common elements shown in Exhibit C with respect to the new Unit 1105/1106 shall be 1.32371%, and Exhibit C shall be deemed amended accordingly.
- 5. <u>COMMON ELEMENTS</u>. No Common Elements or Limited Common Elements are being transferred or reallocated except to the extent one wn by Added Exhibit A or as specifically provided in this Amendment.
- 6. <u>CONTINUATION</u>. Except as expressly modified herein, all terms and conditions of the Declaration shall continue in full force and effect.
