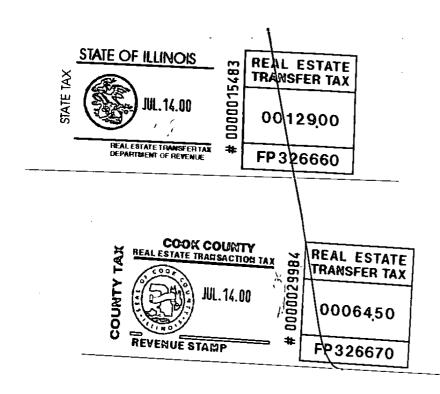
## **Legal Description**
