- 2. That Clune Construction Company, ("Clune Construction") was Owners General Contractor for the improvements on the Real Estate.
- 3. That on, or about February 11, 2000 Clune Construction entered into a Subcontract with Maron Electric Company ("Maron Electric") whereby Maron Electric agreed to furnish Electrical materials and, or labor to Clune Construction for, and in said improvement of the Real Estate.
- 4. That on, or about February 11, 2000 Maron Electric did in turn, enter into a Sub-Subcontract with Tri Star Supply, Inc. ("Tri Star Supply") whereby Tri Star Supply agreed to furnish Electrical materials and, or labor to Maron Electric for, and in said improvement of the Real Estate.
- 5. That on, or about February 11, 2000 **Tri Star Supply** did in turn, enter into a Sub-Subcontract with **Trans Energy**, v hereby Claimant agreed to furnish Electric Baseboard Heaters, (related materials and, or labor) in exchange for payment in the original Contract amount of \$98,725.19.
- 6. That the Subcontracts were entered into between Clune Construction and Maron Electric, and thenceforth between Maron Electric and Tri Star Supply, and thenceforth between Tri Star Supply and thenceforth between the full knowledge and consent of the Owner(s). Alternatively, the Owner(s) knowingly permitted Clune Construction and it's Subcontractors to enter into contracts for, and in said improvement of the Real Estate.
- 7. At the special instance and request of **Tri-Star Supply** and, or **Clune Construction**, and with the full knowledge and express consent or acquiescence of Owner, Claimant furnished extra and additional materials and extra and additional labor on the Real Estate to the value of \$ 9,016.54. Claimant completed providing the additional materials or labor at various times
- 8. On March 23, 2000 Claimant completed and lelivered all work and materials required to be performed under the contract.
  - 9. That Tri Star Supply is entitled to credits for payment in the amount of \$38,085.82.
- As of the date hereof, there is due, unpaid and owing to Claiment, after allowing credits for payments by **Tri Star Supply**, the balance of Sixty-Nine Thousand, Six-Hundred and Fifty-Five Dollars & 91/100, (\$69,655.91), for which with interest, Claimant claims a lien on the Peal Estate and on the improvements furnished at said Real Estate.
