SHAWKAT RAFATI, but the lien is absolute as to all parties.

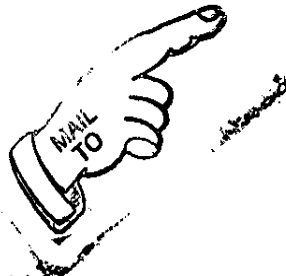
