ORDER

This case came before the court on the debtor's motion, pursuant to 11 U.S.C. § 522(f), for avoidance of a judgment lien asserted by Fleet Business Credit Corporation. By order of January 19, 2000, this court denied the motion, for reasons stated in a memorandum of decision reported at 243 B.R. 688. On May 5, 2000, the District Court reversed this court's decision, in a Memorandum Opinion and Order stating that "the bankruptcy court should have granted Chinosorn's motion to avoid the lien." 248 B.R. 324, 328. The District Court remanded the motion to this court "for further proceedings consistent with this opinion." *Id.*


Accordingly, it is hereby ordered that the motion is granted, and that the judgment lien of Fleet Business Credit Corporation, attaching to the debtor's homestead at 6919 N. Lorel Ave., Skokie, Illinois (Permanent Real Estate Index Number 10-33-109-046-0000), is avoided.

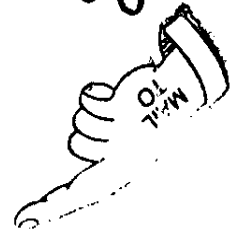
