#### LEASE TERMINATION AGREEMENT AND CONVEYANCE OF IMPROVEMENTS AND PERMITS



This Lease Termination Agreement (this "Agreement") is made as of the 3/st day of \_\_\_\_\_\_, 2000, by and between Northwestern University, an Illinois corporation ("Lessor") and American Hospital Association, an Illinois corporation ("Lessee").

#### WITNESSETH

WHEFEAS, Lessor and Lessee have heretofore entered into that certain Lease dated October 1, 1955, ine Supplementary Lease dated October 1, 1966, the Amendment to Lease dated January 2, 1967, the Amendment #2 to Lease dated October 10, 1973 and a Revaluation Agreement dated Occomber 16, 1988 and three additional amendments to lease (which leases and all such amendments and agreements shall hereinafter be referred to collectively as the "Lease"), by which the premises described therein (the "Premises") were leased by Lessor to Lessee for a term ending September 30, 2054;

WHEREAS, portions of the Lease were recorded on November 10, 1955 as Documents No. 16417701, and January 19, 1989 as Document No. 89031832;

WHEREAS, Lessor and Lessee desire to te minate the Lease;

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the sufficiency of which is hereby acknowledged. Lessor and Lessee hereby agree that the Lease shall be terminated as the date of this Agreement. From and after such date neither party shall have any further rights or obligations under the Lease, and the Lease shall be null and void, except for such obligations of the parties as were intended by their terms to extend beyond termination of the Lease.

Lessee hereby transfers, conveys and assigns to Lessor all of Lessee's right, title and interest in and to any buildings, structures, improvements, fixtures or other property located on the Premises on the date of this Agreement, in their "as is" condition on such date.

Lessee also hereby transfers, conveys and assigns to Lessor all of Lessee's right, title and interest in, to and under the Permit issued by the City of Chicago for the use of a steam tunnel/conduits for 840 North Lake Shore Drive, known as Account No. 6-203, and any other rights, interests, entitlements or permits pertaining to the Premises..
