Lot 7 in the County Clerk's Division of Unsubdivided Lands in the Northeast 1/4 of Section 17, Township 36 North, Range 14, East of the Third Principal Meridian, all lying Easterly of the Illinois Central Railroad according to the recorded Plat thereof more particularly described as follows to wit: Beginning at a point on the Southerly line of Grand Trunk Western Railroad Company's original 100-foot right of way, said right of way line being parallel with and distant 50.0 feet Southwesterly at right angles from the centerline of said Grand Trunk Western Railroad Company's East bound or Southerly main track and said point of beginning, being distant 136.6 feet Northwesterly, as measured along said right of way line from the intersection of said right of way line with the East line of said Section 17; thence Northwesterly along said right of way line, a distance of 277.0 feet; thence West, a distance of 24.0 feet on a line parallel with the South line of said Northeast 1/4 of Section 17; thence Southwesterly at an angle of 55 degrees to the left from the preceding course produced West, a distance of 78.7 feet to the Northeasterly line of the right of way of the Baltimore and Ohio Chicago Terminal Railroad (formerly the Chicago Central and Calumet Terminal Railroad); thence Southeasterly along said Northeasterly right of way line a distance 140.8 feet; thence Easterly on a curve to the right with a radius of 655.0 feet, a distance of 182.6 feet to the point of beginning, in Cook County, Illinois


