## AN ORDINANCE APPROVING A PLAT OF RESUBDIVISION OF LOTS 1 AND 2 OF THE HOMEWOOD JEWEL-OSCO RESUBDIVISION

WHEREAS, Albertson's, Inc., has petitioned for the resubdivision of Lots 1 and 2 of Jetco Subdivision hereinafter described and commonly known as 3105-3153 183rd Street, Homewood, Illinois;

**WHEREAS**, the Village Plan Commission conducted a review of this resubdivision at its June 7, 2000, meeting and failed to recommend approval of the resubdivision; AND

WHEREAS, the Village Board of Trustees conducted a review of this resubdivision at its July 11, 2000, meeting and verbally approved this resubdivision;

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Homewood, Cook County, Illinois, that:

#### **SECTION ONE - FINDINGS OF FACT:**

- (a) The subject property includes two parcels totaling 4.13 acres.
- (b) The parcels include Lots 1 and 2 of the Jetco Subdivision consisting of an outlot at the northwest corner of the parcel (Lot 2) and a second lot encompassing the remainder of the parcel (Lot 1).
- (c) The subject property is located in an R-1, Single Family Residential District; however, uses allowed in the B-2 District are allowed as permitted uses at this site.

(d) The petitioner proposes to consolidate existing Lots 1 and 2 of the Jetco Subdivision into one lot and create a new outlot 2 in the northeast corner of the parcel.
