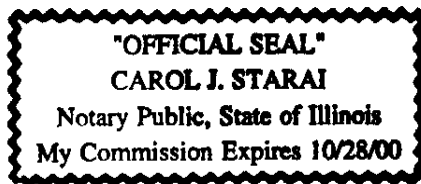

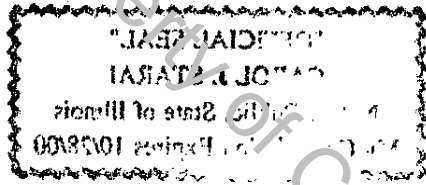

2295 & 2335 LANDWEHR ROAD, VILLAGE OF NORTHBROOK**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Northbrook Board of Trustees on **TUESDAY, JULY 27, 1999 at 8:00 P.M.** in the Village Hall, 1225 Cedar Lane, Northbrook, Illinois, for the purpose of considering a proposed annexation agreement by and between the Village of Northbrook and KOGEN-ZIVIN DEVELOPMENT, INC. concerning the annexation and development of the properties commonly known as 2295 & 2335 Landwehr Road.

The property for which the annexation pertains is generally located on the east side of Landwehr Road, north of Donovan Glen Court and south of Floral Drive, and is legally described as follows:

LOTS 1 AND 2 IN WIDMER'S SUBDIVISION, BEING A SUBDIVISION OF PART OF THE NORTH 5 ACRES OF THE WEST 10 ACRES OF THE SOUTH HALF OF THE SOUTH HALF OF THE SOUTHEAST QUARTER OF SECTION 17, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN.
