COVENANTS

- 1. PACMENTS: I agree to make all payments on the secured debt when due Unless we agree otherwise, any payments you receive from me or for my benefit will be applied first to any amounts I owe on the secured debt (exclusive of interest or principal), secondly, to interest, and thirdly to principal. If partial prepayment of the secured debt occurs for any reason, it will excuse any subsequently scheduled payments until the secured debt is paid in full.
- 2. CLAIMS AGAINST TITLE: I will pay all taxes, assessments, liens, and encumbrances on the property when due and will defend title to the property against all claims which would impair the lien of this mortgage. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the non-existence of a defau't or any other defense of Borrower to acceleration and foreclosure.
