Beginning at the intersection of the South line of Olive Street with the Southwesterly line of Rand Road;

Thence Northwesterly along the Southwesterly line of Rand Road to its point of intersection with the Northwesterly lot line, as extended Southwest, of Lot 15 in C.E. Taylor's Arlington Heights Acres, a subdivision of part of the Northwest 1/4 of the Southwest 1/4 aforesaid lying North of Rand Road;

Thence Northeasterly along said lot line as extended to its intersection with the Northeasterly lot line of Lot 15 in C.E. Taylor's Arlington Heights Acres, aforesaid;

Thence Southwesterly along said Northeasterly lot line of Lot 15, and along the Northeasterly lot lines of Lots 16 and 17 in said C.E. Taylor's Arlington Heights Acres to the West line of the East 1/2 of the Southwest 1/4 of Section 21;

Thence North along said West line aforesaid to the South line of Willow Road;

Thence East along the South line of Willow Road to its intersection with the West line of Willow Estates Subdivision, a subdivision in the East 1/2 of the Northeast 1/4 of the Southwest 1/4 of Section 21;

Thence South along the West line, as extended, of Willow Estates Subdivision to the South line of Olive Street;

Thence West along the South line of Olive Street to the point of beginning.
