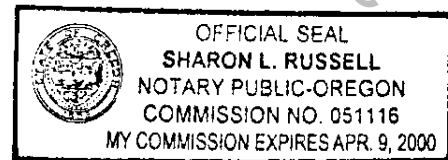

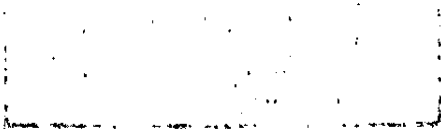


EXHIBIT A
