That Section 14-70 through 14-75 of the Municipal Code of Hanover Park requires the owner or occupant of any property within the Village to cut all weeds on the property exceeding eight inches in height after notice or the Village shall cut the weeds and place a lien on the property.

That on May 25, 2000, the owners of the above described property were notified in writing in accordance with the above mentioned ordinance provisions, but that said owners neglected and/or refused to cut the weeds.

That on June 7, 2000, the Village of Hanover Park, Illinois caused said weeds to be cut, removed, and destroyed and the reasonable cost and expense incurred for the work was \$170.00, and that said sum remains unpaid.
