MODIFICATION AGREEMENT, made July 26,2000, between NATIONAL CITY BANK OF MICHIGAN/ILLINOIS fikia FIRST OF AMERICA BANK-ILLINOIS, NA, (THE "MORTGAGEE") and RITA J. MILLER AS TRUSTEE UNDER TRUST AGREEMENT DATED AUGUST 29, 1988, (the "Mortgagor").

- As designated by the initials of the Mortgagor and by an "X" in the box adjacent, it is agreed that, as of the date 2. hereof, certain provisions of the Note or the Mortgage, or both, shall be, and the same are, hereby modified and amended as so indicated:

MODIFICATION OF NOTE AND MORTGAGE

The Note or Mortgage, or both, are further modified as follows:

The name of the Mortgagor as noted in the mortgage made and entered into on the 30th day of April, 1996, is hereby modified to Rita J. Miller as Trustee under Trust Agreement dated August 29, 1988, and the name of the Mortgagee is hereby modified to National City Bank of Michigan/Illinois.

The parties agree that the Note and the Mortgage, including such changes, modifications, and amendments as 3. are herein contained, are in full force and effect with respect to each and every term and provision thereof and nothing herein contained shall in any manner affect the lien of the Mortgage on the Mortgaged Premises. Nothing contained herein shall in any way impair the Note or the Mortgage or the security now held for the indebtedness thereunder, or alter, waive, annul, vary or affect any provision, term, condition or covenant therein, except as herein provided, nor affect or impair any rights, powers, privileges, duties or remedies under the Note and the Mortgage, it being the intent of the parties that the terms and provisions thereof shall continue in full force and effect, except as specifically modified hereby.
