### **MODIFICATION AGREEMENT**

This Agreement, made as of the 1st day of March, 2000, by and between Banc One Community Development Corporation, a Delaware Corporation, (Lender), and East Lake Management & Development Corporation, (Borrover).

#### WITNESSETH:

Whereas, the Borrower heretofore executed a contain Mortgage, Security Agreement and Assignment of Rents and Leases dated September 30, 1997 and recorded October 28, 1997, in the office of the Recorder of Deeds of Cook Coun'y, Ilinois, as Document Numbers 97805876, conveying real estate in Cook County, Illinois, legally described in Exhibit A attached hereto and made apart hereof by this reference (Mortgage); which said Mortgage was given to secure the payment of one certain Note executed by the Borrower in 'ne' sum of THREE HUNDRED FIFTY THOUSAND AND 001/00 (\$350,000.00) DOLLARS.

Whereas, said Mortgage securing said Note is a valid lien of the promise described in said Mortgage, for the principal sum of \$350,000.00. AND

Whereas, said Note by its terms, is due and payable September 30, 1998. AND

Whereas the parties hereto have agreed upon a modification in said Mortgage upon the terms and conditions hereinafter set forth. NOW

Therefore, in consideration of the premise and the mutual promises and agreements herein after made by and between the parties hereto, the said parties do hereby mutually promise and agree as follows:

- The principal balance outstanding as of March 1, 2000 is THREE HUNDRED FIFTY THOUSAND AND 00/100 (\$350,000.00) DOLLARS.
- The due date of said Note is extended to March 1, 2001.
- 3. Loan repayment remains at interest only, monthly and rate remains at 12%.

And the said parties hereto further mutually agree that all provisions, stipulations, powers and covenants in said Note and in the Mortgage contained, as modified, shall stand and remain unchanged and in full force and effect for and during said modified period, except only as the same are herein and hereby specifically varied or amended; and further that in the event of the failure to pay the same principal sum of \$350,000.00 or so much as is here outstanding as herein provided, or to keep, fulfill or perform any or all of the convenants and agreements contained in said Mortgage, then the whole of said principal sum shall, as the election of the holder of said Note, become at once, without notice, due and payable and may be collected together with all accrued interest thereon, in the same manner as if said modification had not been granted. anything hereinbefore contained to the contrary notwithstanding.

And it is expressly understood and agreed by and between the parties hereto that the convenants and agreements herein contained shall bind, and insure, to the respective heirs, executors. administrato s, legal representative and assigns to the said parties hereto.
