

WARRANTY DEED

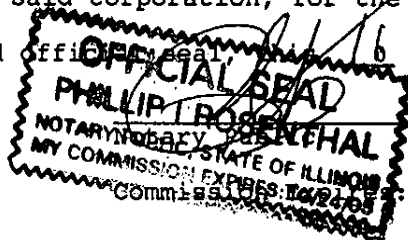
