- 3. The interest rate is hereby reduced to Eight and one-quarter percent (8-1/4%) per annum, with a corresponding reduction in the rate for any defaults under the terms of the Amended Note to Eleven and one-quarter percent (11-1/4%) per annum.

Strike numbered Paragraph 1 in its entirety, and in lieu thereof substitute the following:

1. The payment of the Amended Note, amended by Second Amendment to Note, with a current principal balance of \$854,486.52, and a maturity date of July 1, 2002 (the "Second Amended Note").

All references in the original Mortgage to the Note include the Amended Note and the Second Amended Note.

All other terms and conditions of the Amended Note and the Mortgage, except as modified herein, remain unchanged.
