AGREED ORDER

THIS MATTER coming to be heard upon the agreement of the parties. The parties having resolved and settled all matters in controversy and the Court being duly advised in the premises;

IT IS HEREBY ORDERED:

1. The Defendant, VALERIE ORNSTEIN, shall pay the Plaintiff, GRUND & STARKOPF, P.C., \$50,000.00 as and for any and all attorneys' fees and costs incurred on her behalf as set forth in Plaintiff's Verified Complaint for Breach of Contract and Quantum Meruit.
