#### 5949-5951 NORTH ODELL CONDOMINIUM ASSOCIATION

Article 4. The purposes for which the corporation is organized are:

To maintain, operate and manage a condominium residential development located at 5949-5951 North Odell, Chicago, Illinois.

The members of the 5949-5951 North Odell Condominium Association shall consist of the respective Unit Corners of the Property, known as and located at the above described address in Chicago, Illinois, in accordance with the respective percentages of ownership interest in the Common Elements of the Property owned by the respective Unit Owners, as said terms are defined in the Declaration of Condominium Ownership for 5949-5951 North Odell Condominium Association executed by R & M Development, LLC, which Declaration will be recorded in the Office of the Recorder of Deeds, Cook County, Illinois.
