

WHEREAS, Owner and the Board of Managers of the 1365-67 North Mohawk Condominium Association (the "Board") desire to amend <u>Definitions</u>, Subparagraph (k), and Article 4(b), <u>Use and Ownership of the Common Elements</u>, and Site Plan of the Plat of Survey referred to on the Declaration as Exhibit "D" and recorded simultaneously therewith as (the "Plat") in conformance with the requirements of the Condominium Property Act, 765 ILCS 6Q5/1 (the "Act") by recording the amended Site Plan of the Plat of Survey referred to as Exhibit"D" (the "Amendment to Site Plan") and made a part of this First Amendment to Declaration of Condominium Ownership and By-laws, Easements, Restrictions and Covenants for the 1365-67 North Mohawk Condominium (the "First Amendment")

WHEREAS, Owner and the Board have determined that consistent with the Amended Plat, Limited Common Elements, <u>Definitions</u>, Subparagraph (k), and Article 4(b), <u>Use and Ownership of the Common Elements</u>, shall be amended with the provision that the Limited Common Elements shall include Parking Units as delineated more specifically on the Amendment to Site Plan of the Survey as P-1S, P-2S, P-3S, P-1N, P-2N, P-3N.

NOW, THEREFORE, this document amends the Declaration as follows:

1. Amends <u>Definitions</u>, Subparagraph (k), and Article 4(b), <u>Use</u> and <u>Ownership of the Common Elements</u>, by inserting the following language:

Limited Common Elements shall include Parking Units as delineated more specifically on the Amendment to Site Plan of the Survey as P-1S, P-2S, P-3S, P-1N, P-2N, P-3N.

- 2. This First Amendment to the Declaration is made pursuant to the applicable provisions of the Declaration and the Act.
- 4. This First Amendment to the Declaration is executed by HELPE ENTERPRISES, L.L.C., an Illinois Limited Liability Company, as aforesaid, in the exercise of power and authority conferred upon and vested in it as such Owner (and said Owner hereby warrants that it possesses full power and authority to execute this instrument). It is expressly understood and agreed by every person, firm, or company hereafter claiming any interest under this First Amendment or the execution of this Declaration for the sole purpose of subjecting the title holding interest to the terms of this First Amendment to the Declaration; that any and all obligations, duties, convents, and agreements of every nature herein set forth by said Owner, as aforesaid, to be kept or performed, are intended to be kept, performed, and discharged by Owner and its successors. In event of conflict between the terms of this paragraph and of the reminder of the First Amendment or

the Declaration on any question of apparent liability or obligation resting upon said Owner, the exculpatory provisions hereof shall be controlling.
