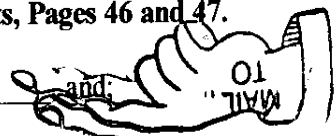

RELEASE AND WAIVER OF LIEN

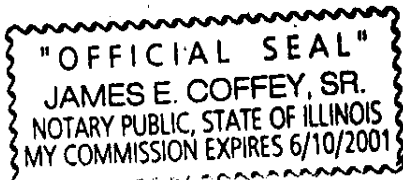
