THIRD AMENDMENT TO THE

DECLARATION OF CONDOMINIUM OWNERSHIP AND BY-LAWS, EASEMENTS,
RESTRICTIONS AND COVENANTS FOR
WESTGATE VALLEY TOWNHOMES CONDOMINIUM ("DECLARATION")

This Third Amendment to the Declaration, dated this 29th day of August, 2000, is made by GateWest, LLC (herein the "Declarant").

RECITALS

- A. Pursuant to that certain Declaration of Condominium Ownership And By-Laws,
 Easements, Restrictions and Covenants for the WestGate Valley Townhomes
 Condominium (the 'Declaration"), recorded in the office of the Recorder of
 Deeds of Cook County, Illinois on March 27, 2000, as Document No.
 00214379, The Declarant submitted certain real estate (the "Property") to the
 provisions of the Illinois Condominium Property Act (the "Act").
- B. Pursuant to Article IV of said Declaration, the Declarant has reserved the right and option to add certain additional property to the Condominium.

Acting pursuant to the provisions of Article IV of the Declaration, the Declarant intends to add certain improved real property as described in Exhibit "A", a copy of which is attached hereto and incorporated herein as if fully set forth herein.

NOW, THEREFORE, the Declarant, as the title holder of the property described in Exhibit "A" hereto does hereby submit said real property to the terms and conditions of the Declaration and the Act and hereby amends the Declaration as follows:

- 1. That the property identified as Exhibit "A" hereto, is hereby added to the Property (as defined in the Declaration) and is hereby submitted to the provisions of the Act as part of the Condominium in accordance with, and to be governed in all respects by, the terms and provisions of the Declaration.
- 2. That Exhibit "A" to the Declaration, as amended, setting forth the Plat of Survey of the Real Estate which has heretofore been submitted to the Act, is hereby amended in conformity with the survey identified as Exhibit "B", (consisting of 4 pages marked in the lower left corner as 9, 9A, 10 and 10A) which is attached hereto and incorporated herein as if fully set forth herein.
- 3. That Exhibit "B" to the Declaration, as americal, setting forth the percentage of Interest of each of the Units in the Common Elements, is hereby amended in its entirety in conformity with Exhibit "C", a copy of which is attached hereto and incorporated herein as if fully set forth herein.
- 4. That the additional Common Elements contained in the Property which has been added by this instrument are hereby granted and conveyed to the grantees of all Units, including the grantees of the Units heretofore

- 5. That all General Provision as to Units and Common Elements contained in the Declaration, as amended, shall apply to the property submitted hereby.
- 6. That except as expressly set forth herein, the Declaration, as amended, shall remain in full force and effect in accordance with its terms.
