- 8. Install three new vents capp and windows front door with white aluminum capping.
- 9. Install ten feet facia board front gable.
- 10. Install new seamless aluminum gutters and down spout entire house.
- 11. No work at all back addition 13x7

On May 19, 2000 claimant completed the furnishing and performance of all work, labor & services, and had delivered all material and fixtures required by the contract.

\$ 6,600.00 is due to Gillman Lumber & Construction Co., for the furnishing, performance and delivery of the work, labor, services, materials and fixtures, including extras, after allowing the owners all credits deductions & setoffs.
