(3) agree that the Undivided interest assigned to Units 2012 and 1709 shall not be modified as a result of the foregoing assignment of the Space P1-04 Parking Right and (4) agree that this Amendment and the assignment of the Space P1-04 Parking Right provided for herein shall not transfer or in any way affect other Parking Rights now or hereafter assigned to Unit 2012.
