LAST WILL AND TESTAMENT

OF

#### NAOMI WELLS

I, NAOMI WELLS, a resident and domiciled in Cook County, State of Illinois, make, publish and declare this to be my last Will and revoke all other Wills and Codicils by me made.

FIRST: I direct my Executor hereinafter named to pay out of the assets of my residuary estate all my just debts due at the time of my death, funeral expenses, expenses of my last illness and all costs of administration of my estate.

SECOND: I further direct that all estate, transfer, inheritance and succession taxes (including interest and penalties thereon, if any) which shall become payable by reason of my death shall be paid out of and be charged generally against the principal of my residuary estate without reimbursement from any person; except that this provision shall not be construed as a waiver of any right which my Executor has, by law or otherwise, to claim reimbursement for any such taxes which become payable on account of property, if any, over which I have a power of appointment. My Executor, in his discretion, shall have the right to litigate compromise or settle any such taxes and any action taken by my Executor with respect thereto, including deposits made to secure the payments thereof shall be conclusive on all persons.

THIRD: I give and bequeath to my husband, JOSEPH WELLS, from my personal property, my stereo system and bedroom suite.

FOURTH: I give and bequeath to BRENDA WELLS PRINCE all other furniture and furnishings in my home that I may own at the time of my death. If she should predecease me then her interest shall pass to my son, MICHAEL A. WELLS.

FIFTH: I give, devise and bequeath all my catering equipment to my friend, CHRISTINE OWENS. If she does not survive me then her interest shall pass to CALLISTA MC LAWRENCE of Castries, St. LUCIA in the Virgin Islands.

SIXTH: I give, devise and bequeath all equipment, furniture and fixtures located in or connected to my beauty salon to my son, LEONARD E. WELLS.

SEVENTH: I give, devise and bequeath to my son CURTIS JEROME WELLS, his choice of my two color television sets and the remaining color television to my son, MICHAEL A. WELLS.

EIGHTH: I give to my husband, JOE WELLS, a life estate in the first floor apartment and basement of 7035 South May.

NINETH: I give to my children the income from the second floor apartment of 7035 South May so long as JOE WELLS shall live. Upon JOE WELLS' death or if he should predecease, I direct my Executor to sell the apartment building at 80% of its appraised value, with first option to purchase to BRENDA W. PRINCE, then MICHAEL WELLS and finally LEONARD WELLS, in that order. After the property is sold the proceeds from the sale shall be distributed equally to BRENDA WELLS PRINCE, MICHAEL WELLS, CURTIS JEROME WELLS and LEONARD WELLS, as joint tenants.

TENTH: I give and bequeath the residue of my estate and all lapsed legacies to my daughter, BRENDA WELLS PRINCE.

ELEVENTH: My Executor shell collect the proceeds of all insurance policies on my life which at the time of my death are payable to myself, my estate, my frecutor, administrators or assigns, and such proceeds shall become and constitute a part of the assets of my estate. My Executor may use such proceeds in a like manner as other property of my estate for the purpose of paying any obligations of my estate, and any portion of such proceeds not so used shall become a part of my general estate.

TWELFTH: I hereby appoint MICHAEL WELLS, or his designee, Executor of this Will, and LEONARD WELLS, or his designee, as alternate Executor if MICHAEL WELLS is unable or chooses not to serve, with the following powers, and any others that may be granted by law, to be exercised in his discretion without posting surety bond and without court order:

- To employ attorneys, auditors, depositaries, proxies and agents, with or without discretionay powers; and to keep any property in the name of an executor or a nominee, with or without disclosure of any fiduciary relationship, or in bearer form:
- (b) To collect, pay, contest, compromise, or abandon claims of or against my estate, whereever situated; and to execute contracts, conveyances, and other instruments, including instruments containing covenants and warranties binding upon and creating a charge against my estate, and containing provisions excluding personal liability;
- To sell any real or personal property of my estate, for cash or credit at public or private sales, for the purpose of paying all my just debts due at the time of my death.

IN WITNESS WHEREOF, I have set my hand and seal to this my Last Will and Testament, in Cook County, State of Illinois, this Come Clarks Office 29th day of May, 1985.
