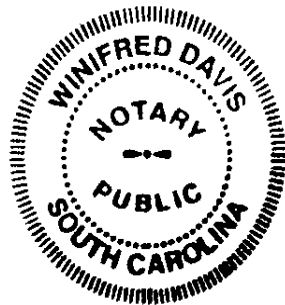

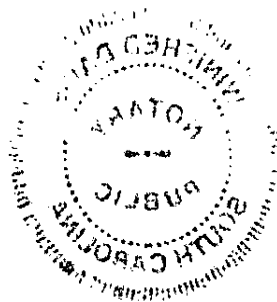
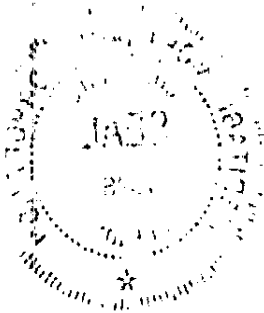

THAT PART OF LOTS 7 AND 8 IN BLOCK 5 IN PAYNE'S ADDITION TO EVANSTON, IN THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 12, TOWNSHIP 41 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT IN THE WEST LINE OF LOT 7, 12 FEET SOUTH OF THE NORTHWEST CORNER THEREOF; THENCE EAST 50 FEET ON A LINE PARALLEL WITH THE NORTH LINE OF SAID LOT 7; THENCE SOUTH PARALLEL WITH THE EAST LINE OF SAID LOTS 7 AND 8 TO THE SOUTH LINE OF SAID LOT 8; THENCE WEST TO THE SOUTHWEST CORNER OF SAID LOT 8; THENCE NORTH ALONG THE WEST LINE OF SAID LOTS 7 AND 8 TO THE PLACE OF BEGINNING (EXCEPTING FROM SAID TRACT THE EAST 25 FEET THEREOF), IN COOK COUNTY, ILLINOIS.
