## SUPPLEMENT NO. 2 TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR CAPITOL HILL LOFF'S CONDOMINIUM AND PROVISIONS RELATING TO COMMERCIAL PROPERTY

This Supplement is made and entered into 5° Capitol Hill Lofts, Inc., an Illinois corporation ("Declarant").

#### RECITALS

Declarant recorded the Declaration of Condominium Ownerstip for Capitol Hill Lofts Condominium and Provisions Relating to Commercial Property (the "Declaration") on July 3, 2000, in Cook County, Illinois as Document No. 457646.

In Article Eight of the Declaration, Declarant reserved the right and power of add additional portions of the Premises to the Condominium Property as "Added Property" and to submit such portions to the Act and to the Declaration. Declarant exercised this right and power by recording Supplement No. 1 to the Declaration in Cook County, Illinois as Document No. 00625034. Declarant desires once again to add and submit certain real estate to the provisions of the Declaration and to the Act as part of the Condominium Property.

NOW, THEREFORE, Declarant does hereby supplement and amend the Declaration as follows:

1. <u>Terms</u>. All Terms used herein, if not otherwise defined herein, shall have the meanings set forth in the Declaration.

- 2. Added Property/Amendment of Exhibit B. The portion of the Premises which is legally described in the Second Amendment to Exhibit B attached hereto is hereby made subject to the Condominium Declaration as "Added Property" and is also submitted to the provisions of the Act. Exhibit B to the Condominium Declaration is hereby amended to include the Added Property which is legally described in the Second Amendment to Exhibit B attached hereto.
- 3. The Added Units/Amendment of Exhibit C. Exhibit C, as amended and supplemented, identifies each Unit in the Property and assigns to it an identifying symbol and identifies each Garage Space in the Property and assigns to it an identifying symbol. In addition, page 5 is hereby amended to delete certain balconies as set forth in the amended page 5, page 6 is hereby amended to reflect additional balcony dimensions as set forth in amended page 6, and pages 7, 8 and 9 are nearly amended to reflect the existence of balconics and be as set forth in the amended pages 7, 8 and 9.
- 4. Amendment of Exhibit D. To reflect the addition of the Added Units, the list of the Undivided Interests of the Units as shown in Exhibit D to the Condominium Declaration is hereby amended to be as set forth in the Second Amended and Restated Exhibit D, which is attached hereto.
- 5. Covenants to Run With Land. The covenants, conditions, restrictions and easements contained in the Condominium Declaration, as amended by this Supplement, shall run with and bind the Condominium Property, including the Added Property and Added Units.
- 6. Continuation As expressly hereby a nen led, the Condominium Declaration shall continue in full force and effect in accordance with its terms.
