

MODIFICATION AGREEMENT

- 1. To <u>INCREASE</u> the principal sum of the <u>Mortgage</u> from <u>TWENTY TWO 7.4.OUSAND FIVE HUNDREDDollars</u> and 00/100, (\$22,500.00) to <u>THIRTY FIVE THOUSANDDOllars</u> and 00/100, (\$35,000.00).
- 2. Except as specifically modified above, all terms and provisions of the Moltage remain unmodified and continue in full force and effect.
