Ravinder Nath above named on my behalf and also to furnish the necessary affidavit for attestation of the mutation of property of my share mentioned above, in favor of said Sh. Ravinder Nath in my or his absence, and to do all acts, deeds and things required to be done in connection with the above purposes and whatever acts, deeds and things are lawfully done by my said attorney, that shall be deemed the acts, deeds and things done by me as if I were personally present and I undertake to ratify and confirm the same.
