THIS MORTGAGE SPREADER AGKEEMENT is made as of October 3, 2000, by and between PATRIA PARTNERS, LLC, an Illinois limited liability company (hereinafter referred to as "Mortgagor") and COMMERCIAL LOAN CORPORATION, an Illinois corporation (hereinafter referred to as "Mortgagee"):

#### RECITALS:

A. - 1. The foregoing recitals are true and correct and are incorporated herein by this reference.
- 2. The lien of the Mortgage is hereby spread and extended to cover, encompass, include and
