Property, allow the Property to deteriorate, or commit waste on the Property. - 15. Governing Law; Severability. This Security Instrument shall be governed by federal law and the law of the jurisdiction in which the Property is located. (C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding Three / Quarters percentage points (2.7500 %) to the Current Index. - **B.** Hazard Insurance. So long as the Owners Association maintains, with a generally accepted insurance carrier, a "master" or "blanket" policy on the Condominium Project which is satisfactory to Lender and which provides insurance coverage in the amounts, for the periods, and against the hazards Lender requires, including fire and hazards included within the term "extended coverage," then:
