EXHIBIT A TO UCC-2 FINANCING STATEMENT

enumeration of any specific articles of property shall in nowise result in or be held to exclude any items of property not specifically mentioned;

(e) all right, title and interest of Debtor, of whatever character (whether as owner, chattel lessee or otherwise, whether vested or contingent and whether now owned or hereafter
