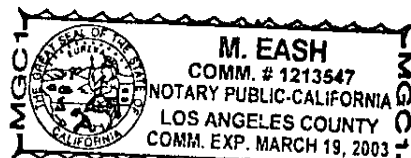

MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on AUGUST 16, 1993. The Mortgagor is ANTHONY E. GIES AND BARBARA R. GIES AS HUSBAND AND WIFE ("Borrower").

This Security Instrument is given to FIRST OF AMERICA BANK-KANKAKEE/WILL COUNTY, N.A., which is organized and existing under the laws of UNITED STATES OF AMERICA, and whose address is ONE DEARBORN SQUARE KANKAKEE, IL 60901 ("Lender").

Borrower owes Lender the principal sum of ONE HUNDRED THIRTY SIX THOUSAND FOUR HUNDRED AND NO/100 Dollars (U.S.\$ 136,400.00).
