



LEGAL DESCRIPTION

Unit No. <u>17-G</u> and Unit Nos. <u>G-111 and G-112</u> in the 1344 North Dearborn Private Residences Condominium as delineated on a survey of the following described real estate:

Lot 4 and the North ½ of Lot 5 in the Subdivision of Block 15 (except the North 47 10/12 feet) in Bronson's Addition to Chicago in Section 4, Township 39 North, Range 14, East of the Third Parcipal Meridian, in Cook County, Illinois, also Lot 6 and the South ½ of Lot 5 in Borden Miller and Woolfing's Subdivision of Block 15 (except the North 47 10/12 feet thereof) in Bronson's Addition to Chicago, which survey is attached as Appendix "A" to the Declaration of Condominium recorded as Document Number 99936671; together with its radivided percentage interest in the common elements, all in Cook County, Illinois.
