HOUSING REHABILITATION PROGRAM
SUBORDINATION AGREEMENT



WHEREAS, Jacek P. Latallo and Maria Latallo, His Wife, (hereinafter called "the Owner") are desirous of executing a mortgage and note for their principal residence located at 8845 McVicker Avenue, Morton Grove, Illinois:

WHEREAS, 1st Security Federal Savings Bank, 936 N. In order to effectuate this Agreement, the Village hereby agrees that it will accept no payment on account thereof nor any security therefor unless and until the Lender has been paid and satisfied in full for all of its obligations due under the Mortgage and Note, dated September 26, 2000, in the amount of ONE HUNDRED FIFTY-EIGHT THOUSAND FIVE HUNDRED AND NO/100 (\$158,500.00) and known as Loan Number 7364-8 said Mortgage and Note being fully executed by the Owner. The Owner further agrees not to make any payments or give any security to the Village except in conformity with this Agreement.

This Agreement shall be binding upon the executors, administrators, personal representatives, successors and assigns of the parties hereto.
