LOAN MODIFICATION AGREEMENT

THIS AGREEMENT, is made and entered into as of September 5, 2000, but made effective November 1, 2000 by and between MID TOWN BANK AND TRUST COMPANY OF CHICAGO, an Illinois corporation ("BANK"), MID TOWN BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED August 20, 1999 A/K/A TRUST NO. 2273 ("MORTGAGOR") & GEORGE ZIAMP ARAS and Mary ZIAMPARAS, HIS WIFE, ("BORROWERS").

WHEREAS:

- 1. The BORROWER has heretofore executed a Promissory Note dated November 1, 1999 in the principal amount of \$336,500.00 of which the BANK is presently the holder;
- 2. The NOTE is secured by a Mortgage, Assignment of Rents & Security Agreement (Chattel Mortgage) dated November 1, 1999 and recorded in the Recorder's Office of Cook County, Illinois, as document number 09045287 ("MORTGAGE"), conveying to BANK certain real estate described in Exhibit "A" attached hereto and by this reference incorporated herein ("REAL ESTATE");
- 3. The NOTE is further secured by a Collateral Assignment of the Beneficial Interest in that certain Land Trust which is known as Mid Town Bank and Trust Company of Chicago a/t/u Trust Agreement dated August 20, 1999 a/k/a Trust No. 2273 ("ASSIGNMENT OF BENEFICIAL INTEREST") which land trust holds title to the described REAL ESTATE;
- 4. The BANK has disbursed to BORROWER the sum of \$336,500.00 which amount represents the entire principal sum of the indebtedness evidenced by the NOTE, on which there is an outstanding balance of \$68,465.16.
- 5. The interest rate evidenced on said NOTE is 1.5% ("the margin") over the Prime Rate of interest per annum. For purposes of this loan the "Prime Rate" shall mean the prime rate of interest as announced by Lender from time to time;
- 6. The maturity date evidenced on said NOTE is November 1, 2000;
- 7. The BORROWER desires to amend the maturity date as evidenced by the NOTE;

8. The BANK has agreed to such modification pursuant to the terms and conditions of a commitment of the BANK dated September 5, 2000 ("COMMITMENT").

NOW THEREFORE, notwithstanding anything contained to the contrary in the NOTE, MORTGAGE, and in consideration of the mutual covenants, conditions, and premises contained herein, the PARTIES HERETO AGREE AS FOLLOWS:

- A. The MORTGAGE modified hereby shall now secure:
- all obligations incurred for the construction of certain improvements on the REAL ESTATE
 mortgaged therein, including the acquisition cost of the land, and constitutes a "construction
 mortgage" within the meaning of Section 9-313(c) of the Illinois Uniform Commercial Code; and
- all funds advanced pursuant to the COMMITMENT (which advances shall constitute part of the indebtedness secured hereby, whether more or less than the principal amount stated in the NOTE) and the due and punctual performance, observance and payment by BORROWER of all the terms, conditions provisions and agreements provided in the COMMITMENT to be performed, observed or paid by BORROWER.
- B. The maturity date is here'sy amended to November 1, 2001.
- C. Except as modified herein, the terms, covenants and conditions of the MORTGAGE shall remain unchanged and otherwise in full force and effect. In the event of any inconsistency between the terms of this agreement and the terms of the NOTE and/or MORTGAGE, the terms herein shall control.
- D. The lien of the MORTGAGE is hereby modified as security for the payment of the principal sum evidenced by the NOTE and amended by this MODIFICATION AGREEMENT.
- E. This agreement shall be governed by and construed under the laws of the State of Illinois.

This instrument is executed by Mid Town Bank and Trust Company of Chicago not personally but solely as trustee, as aforesaid. All the covenants and conditions to be performed increunder by Mid Town Bank and Trust Company of Chicago are undertaken by it solely as Trustee, as aforesaid and rot individually, and no personal liability shall be asserted or be enforceable against Mid Town Bank and Trust Company of Chicago by reason of any of the covenants, statements, representations or warranties contained in this instrument.
