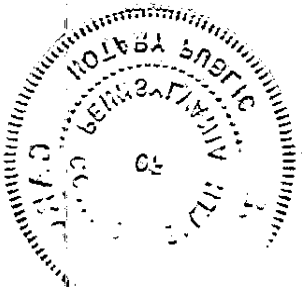
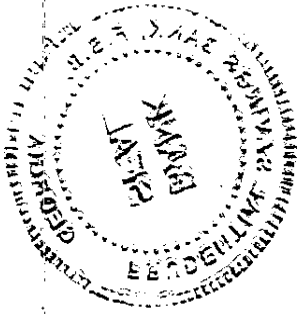


EXHIBIT A
