SARANTAKIS, as Joint Tenants with rights of survivorship ("Grantees") having an address of 292 County Club, Prospect Heights, Illinois,

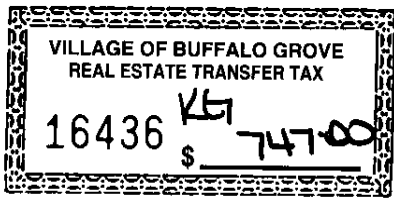
