MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is entered into on this 16 day of March 2000, by and between Gin Hong Gin and Sun King Lee Gin, husband and wife, with an office at 24% 26th Street, Chicago, Illinois 60616, 4. H. . H. (hereinafter referred to 25 "Lessor") and Nextel West Corp., a Delaware corporation, d/b/a Nextel Communications with an office at 300 Park 50 ilevard, 5th Floor, Itasca, IL 60143 (hereinafter referred to as "Lessee").

- Lessor and Lessee entered into a Communications Site Lease Agreement (Building) ("Agreement") on the day of Mich 2000, for the purpose of installing, operating and maintaining a radio communications facility and other improvements. All of the foregoing is set forth in the Agreement.
- The term of the Agreement is for five (5) years commencing upon commercial operation, July 1, 2001, whichever first occurs ("Commen er lent Date"), and terminating on the fifth (5th) anniversary of the Commencement Date, with five (5) successive five (5) year options to renew.
